### Health and Safety Mission Statement

- An ISO 45001:2018 accredited OHS Management System at each of its data centres conforming to local applicable legislation, regulation and statutory requirements.

- Suitable and sufficient information, instruction, training and supervision to enable all Global Switch staff/suppliers/contractors to comply with this policy.
- Safe plant, equipment and systems of work.
- Arrangements for the safe use, handling, storage and transport of articles, material and substances.
- Appropriate management procedures and consultative arrangements to monitor and audit compliance with this policy.
- Appropriate arrangements to assess and control the risks associated with work activities undertaken at Global Switch's premises to reduce injuries and ill health.
- Appropriate procurement policies to ensure that only competent contractors and suppliers are engaged by Global Switch.
- A commitment to consultation and participation of Global Switch staff/suppliers/contractors.
- Consultation and seek advice from external sources and where necessary appoint adequate competent personnel and or consultants to advise on health and safety matters.
- Compliance with legal requirements for health and safety in all Global Switch's data centres and offices.
- Health and Safety performance monitoring and review this policy, the organisation structure and safety arrangements at least annually.

### Responsibilities

All Global Switch staff/suppliers/contractors are required to understand and comply with the requirements of this policy and to actively contribute towards continually improving Health and Safety performance within Global Switch.
